Summary

Review and potentially update the lease contract to reflect new pricing.

4. Drink Price Increase. •

The decision to raise drink prices has resulted in increased revenue.

Further adjustments may be needed, such as raising the price of wine bottles.

Consider the pricing of draft beer pitchers and the possibility of increasing their cost.

5. Upcoming Events and Budgeting. •

Review and approve upcoming events, including a girl state tea, a wedding reception, and a Vietnam veteran commemorative event.

Discuss the budget and catering options for the events, including a pasta dinner and a comedy and dinner event.

6. Event Regulations and Sponsorship. •

Only one open event per year is allowed, while multiple closed events for invited guests are permissible.

7. Cinco de Mayo Party and Other Events. •

Discussion about a Cinco de Mayo party sponsored by the Sons, featuring a band and a potential barbecue event.

Consideration of charging for hall usage by sponsors and the possibility of hosting a monthly spaghetti dinner fundraiser by the ALR.

Plans for a chili cook-off and the need to avoid scheduling conflicts with other events.

8. Chamber of Commerce Lunches. •

Chamber of Commerce lunches were deemed unsuccessful due to low attendance and financial losses.

Consideration of the effectiveness of chamber membership and alternative methods of promotion.

9. House Rules and Maintenance. •

Emphasis on the need for proper house rules, including restrictions on accessing certain areas like the bar.
