Summary

The meeting included Legion members and a guest from Desert Perform Theater seeking a facility tour and historical artifacts. The finance officer highlighted the need for an expensive ice machine and reported on the organization's accounts. E board two discussed confidentiality and storage room usage issues, while the chaplain raised concerns about coordination for rides.
