# → Summary

The meeting of the American Legion, post 519, Department of California, covered various topics including the pledge of allegiance, roll call, event planning, financial updates, and a lawsuit settlement. Significant decisions included settling the lawsuit and drafting letters regarding financial matters and a harassment complaint. Action items included drafting letters to the district and the insurance company regarding financial matters and the harassment complaint. The meeting covered various topics including a reminder about tidbits, updates on a baseball tournament, concerns about the kitchen contract, and ongoing issues with the ABC and raffle laws. Nominations for elections were discussed, with some positions still open. The main objectives of the meeting were to discuss the upcoming elections, settle a supposed lawsuit, address issues with the election hours, handle complaints about dogs at the bar, and plan for the absence of the kitchen cook. Significant decisions include settling the lawsuit within the board's allocated funds and increasing hall rental dues. Action items involve coordinating election hours, addressing the presence of dogs at the bar, finding a replacement for the absent kitchen cook, and enforcing membership card checks at the door. The meeting discussed organizing baseball games in Palm Springs, planning a league with 17 or 8 teams, managing costs, fundraising, and seeking donations for the American Legion. They also explored potential funding sources such as Measure J and grants from the city and county.

#### 14. Dogs at the Bar.

- Ed Complaints about dogs at the bar and the need to enforce rules against it.
- · Discussion about the inappropriateness of dogs at the bar and the need to address the issue with patrons.
- · Decision to enforce rules against dogs at the bar and to have a bartender meeting to ensure compliance.

# 15. Absent Kitchen Cook.

- The kitchen cook is on medical leave until June, and the kitchen staff will cover his duties.
- Issues with the kitchen cook's lack of communication and cooperation in the past.

- · Suggestion to bring up the issue at a general membership meeting and consider incentives for volunteers.

- Consideration of using fields with minimal costs and raising funds for potential future tournaments.

## 18. Organizing Baseball Games.
