## Summary

5. Reinstating \$200 Stipend • 00:31:31

A motion was made to reinstate a \$200 monthly stipend for the American Legion's Thursday night community booth at village fest.

The stipend will cover the \$55 weekly cost for the booth, with additional funds from donations going to support other causes.

6. Discussion on Stipend Discontinuation • 00:35:46

Questions were raised about why the stipend was discontinued and whether it was related to missing funds from the DAV.

It was clarified that the decision to discontinue the stipend was made by the executive board, not by a single individual.

7. Revised Motion for Village Fest Support • 00:40:00

An amended motion was proposed to allocate \$55 per week for the village fest booth, with discussions on the amount and its impact on covering the booth costs.

The amended motion was approved, and arrangements were made to pay the bill monthly. (Motion Passed)

8. VA Hospital Visit • 00:44:15

The commander and Jeff Cole VFW Commander - representative visited the VA hospital to distribute gift stockings to long-term residents.

The visit was described as moving and plans were made to continue such visits in the future.

9. Benefits for World War II Veterans • 00:48:29

World War II veterans are now 100% covered by the VA for medical expenses, including dental and vision care, without the need for a rating.

Veterans were advised to contact the VA for coverage and care.

10. Transportation to Loma Linda • 00:52:43

Veterans needing transportation to Loma Linda for treatment were advised to contact their primary care physician, who can arrange for Uber pick-up and drop-off, with the VA covering the expenses.

Parking and shuttle options at the ACC on Redlands Boulevard were also suggested for convenience.

11. Filing Claims with the VA • 00:56:58

Approximately 2.5 million Impact Act applications have been filed with the VA, with about 600,000 processed.

Advice to file an appeal if denied and seek assistance from service officers for higher level appeals.

Importance of filing claims as they can be backdated upon approval.

12. Transportation for Veterans • 00:59:55

Discussion about arranging rides for veterans to non-VA physicians in Loma Linda with at least a week's notice.

Emphasizing the need for veterans to file claims and appeals for benefits related to exposures during service.

13. Vacant Positions and Membership • 01:01:53

Need for filling vacant historian positions at the post.

Encouragement for members to contribute by reaching out to increase membership and address issues in the community.

14. Visit of National Commander • 01:03:50

Announcement of the national commander's visit to San Diego on December 15 at post 739.
