14. ATM Theft and Security Measures

ATM theft incident resulted in a loss of \$3,400.

Video evidence provided to the police for investigation.

15. Communication Strategy Discussion •

Rusanne - (Motion) Platforms like Facebook, websites, and Constant Contact were considered for communication.

Amado - Use Of Privet Membership List, Concerns were raised about the cost and privacy implications of using Constant Contact.9

16. E-blasts a Membership Communication •
